3. Executive summary

Facing gloomy global economy and declining trend of total trade volume in China, both export volume and value of herbicides in China decreased in 2015 after four years' steady growth. At the same time, the import volume of herbicides declined for the first time since 2011. It is attributed to the following factors: the price of herbicide formulations decreased greatly in 2015; the demand in South America and Africa in H1 2015 dropped because of drought; the adjustment of pesticide export rate had reduced the incentive to export herbicide formulations, and led to lower export price of herbicide technical.


